# THE 2021 AGCO OPERATOR OF THE YEAR CONTEST OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

# ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND PARTICIPANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

The AGCO Operator of the Year Contest (the "Promotion") is a two-part promotion, consisting of (i) a Contest (the "Contest") and (ii) a Fast 100 Giveaway (the "Offer"). By participating in the Promotion, or any component thereof, you unconditionally accept and agree to comply with, and abide by these Official Rules ("Official Rules"), and the decisions of AGCO Corporation and AGCO Canada Limited (collectively, the "Sponsors") and US Sweepstakes & Fulfillment Co. (the "Administrator"), which shall be final and binding in all respects. All applicable federal, state, provincial and local laws and regulations apply.

The intent of the Promotion is to invite owners and employees of U.S. and/or Canadian retailers that provide agricultural chemical application services (each, a "Nominator") to nominate a person who is a custom applicator of agricultural chemicals or an ag-retailer operator that has the primary job of operating application equipment they believe should be considered for Operator of the Year (each, a "Candidate" or "Nominee"). The Contest will include one (1) round of judging to determine three (3) Finalists and a second round of judging to determine (1) Grand Prize winner, all as further described within.

### **PROMOTION ELIGIBILITY:**

Nominators: Each Nominator must be (i) an owner or current employee of a retailer that provides agricultural chemical application services within the U.S. and/or Canada, that (ii) resides within the 50 United States, including the District of Columbia, or Canada, excluding Quebec, and (iii) must be at least 18 years of age and has reached the age of majority in his/her state or province of residence (19+ in Alabama, British Columbia, Nebraska, New Brunswick, Newfoundland and Labrador, Northwest Territories, Nova Scotia, Nunavut and Yukon Territory; 21+ in Mississippi), as of August 1, 2021.

<u>Candidates/Nominees:</u> Each Candidate must be (i) a custom applicator of agricultural chemicals or an agretailer operator that has the primary job of operating application equipment, (ii) a legal resident of the 50 United States, including the District of Columbia, or Canada, excluding Quebec, and (iii) at least 18 years of age and has reached the age of majority in his/her state or province of residence (19+ in Alabama, British Columbia, Nebraska, New Brunswick, Newfoundland and Labrador, Northwest Territories, Nova Scotia, Nunavut and Yukon Territory; 21+ in Mississisppi), as of August 1, 2021.

The Promotion is void in Quebec, Puerto Rico, Guam, the U.S. Virgin Islands, outside the U.S. and Canada, and wherever else prohibited by law.

The Sponsors shall have the right to verify the accuracy of all information submitted and also reserves the right to disqualify any Nominator or Candidate who fails to comply with the Official Rules. Employees, officers, and directors of Sponsors or Administrator, and their respective parent companies, affiliates and subsidiaries, or their respective agencies, representatives, licensees, successors, and assigns (collectively,

"Promotion Entities"), and members of their immediate families (spouses, parents, children, and siblings and their spouses) and those living in the same household of such persons, are not eligible to be a Nominator or a Candidate.

**TIMING:** The Promotion consists of four (4) periods: (a) Nomination Period, (b) First-Round Judging & Finalist Determination Period, (c) Finalist Confirmation Period, and (d) Judging & Grand Prize Winner Determination Period, as defined in the chart below. The Sponsors' computer is the official timekeeping device for this Promotion.

OFFER DESCRIPTION & HOW TO PARTICIPATE: OFFER IS AVAILABLE DURING THE NOMINATION PERIOD OR WHILE SUPPLIES LAST. QUANTITIES ARE LIMITED. ONLY THE FIRST FIFTY (50) ELIGIBLE NOMINATORS WHO SUBMIT A QUALIFYING NOMINATION WILL BE ELIGIBLE. The first fifty (50) Nominators to submit an eligible and Sponsors-verified Nomination during the Nomination Period will qualify to receive one (1) Yeti Tumbler (the "Offer Item"). There is a limit of one (1) Offer Item per Nominator. Each Offer Item has an approximate retail value (ARV) of \$60 USD. Offer Items will be sent to each qualifying Nominator's mailing address provided at the time of nomination submission, within 45 days after the Nomination Period has ended. **THE NOMINATION PERIOD & HOW TO SUBMIT A NOMINATION:** The Nomination Period begins at 12:00:01 AM ET on Sunday, August 1, 2021 and ends at 11:59:59 PM ET on Monday, October 11, 2021 (the "Nomination Period").

To nominate a Candidate, Nominator must complete an official online nomination form ("Nomination Form"), available at <a href="https://www.applylikeapro.com/discover/operator-of-the-year">https://www.applylikeapro.com/discover/operator-of-the-year</a> (the "Website"), with all information requested and submit (each, a "Nomination"). By nominating a Candidate, Nominator represents that Nominator has obtained the express consent of the Candidate to the disclosure of the latter's personal information, including, but not limited to, the Candidate's full name, email address, and phone number, to the Sponsors for the purposes of administration of this Promotion. Once a Nomination is submitted, it cannot be modified.

Sponsors assume no responsibility for late, lost, misdirected, damaged, illegible or incomplete Nominations. To be eligible, all Nominations must be on the official Nomination Form, completed in entirety and submitted via the Website during the Nomination Period. All Nominations become the property of the Sponsors and will not be returned. The Sponsors will review all submitted Nominations and reserves the right in its sole and absolute discretion to reject, disqualify and/or remove any Nomination that violates these Official Rules or are not in the spirit of the Promotion without any notification or warning.

There is no limit to the number of Nominations a Nominator may submit, however, a Nominator may only submit one (1) nomination for any one Candidate. A Nominator may not submit a Nomination for himself/herself.

Nominators are subject to all notices posted online, including but not limited to the Sponsors' Privacy Policy, which can be found at <a href="https://www.agcocorp.com/privacy.html">https://www.agcocorp.com/privacy.html</a>.

By submitting a Nomination, the Nominator understands and grants to the Sponsors an irrevocable, perpetual, non-exclusive worldwide license to use his/her name, Nomination Form, hometown and likeness on the Sponsors' various websites and social media sites and in advertising and/or promotional activities worldwide without compensation, permission or notification.

**FIRST-ROUND JUDGING & FINALIST DETERMINATION:** The First-Round Judging & Finalist Determination Period will begin on Tuesday, October 12, 2021 and be completed on Sunday, October 24, 2021. All Nomination Forms for eligible Candidates received during the Nomination Period, will be judged by a panel of judges (the "Judges") appointed by the Sponsors, at Sponsors' sole discretion, based upon the following equally weighted judging criteria to determine three (3) Contest Finalists (each, a "Finalist").

- A. Service quality and consistency over time in application
- B. Organizational and customer impact—teamwork, mentoring, training and leadership
- C. Service to the local community

The three (3) Candidates that receive the highest total scores based on the judging criteria will each be deemed a potential finalist. In the event of a tie, the tied Candidate with the highest score in Criteria C "Service to the local community", will be deemed the potential finalist. If additional tie-breakers are needed, the tie-breaking mechanism above will be used, however, instead of the highest score in Criteria C determining the potential finalist from among tied entries, the highest scores in each of Criteria B through Criteria A (to the extent needed) will be used to determine the potential finalist. If an additional tie breaker is needed, the tied Candidates will be re-judged by a new panel of Judges, and such process shall be repeated until such tie is broken. All decisions made by Sponsors and Judges will be final.

**FINALIST PRIZES/APPROXIMATE RETAIL VALUE ("ARV"):** There are three (3) Finalist Prizes available to be won. Three (3) Finalists will each receive a trip for two (2) people, winner and one (1) guest, to San Antonio, Texas to attend the 2021 Agricultural Retailers Association Conference & Expo ("ARA Conference") on November 30, 2021 to December 2, 2021. Finalist prize package includes:

- Round-trip, coach-class airfare for winner and one (1) guest to San Antonio, Texas from a major airport nearest the Finalist's residence as determined by Sponsors;
- Two (2) nights hotel accommodations at a hotel of Sponsors' choice based on singleroom/double-occupancy; and
- o Two (2) registration passes to the 2021 ARA Conference in San Antonio, Texas.

The total ARV of each Finalist Prize is \$5,000 USD. The ARV may vary based upon dates of travel and point of departure. The difference between the ARV and actual value of the Finalist Prize will not be awarded. Finalist Prize must be used from November 30, 2021 to December 2, 2021 or forfeited in its entirety.

In the event a Finalist or his/her travel companion engages in behavior during travel that (as determined by Sponsors in their sole discretion) is illegal, tortious, or subjects Finalist and/or travel companion to arrest or detention, Sponsors shall have no obligation to pay any damages, fees, fines, judgments or other costs or expenses of any kind whatsoever incurred by Finalist and/or travel companion as a result of such conduct. SPONSORS SHALL HAVE NO LIABILITY FOR ANY PERSONAL INJURIES, DEATH, PROPERTY DAMAGE, OR OTHER DAMAGES OR EXPENSES RESULTING FROM OR ARISING OUT OF ANY TRAVEL RELATED TO THE PRIZE OR ANY OTHER ASPECT OF FINALIST'S ACCEPTANCE OR USE OF THE PRIZE.

Sponsors are not the provider of ARA Conference ("Event"), which is managed or controlled by an independent third party ("Event Sponsor"), and Sponsors have no power to manage or control the operations of Event Sponsor or any third party provider. Sponsors make no guarantees or warranties about Event Passes or the Event itself. The Event Sponsor and its agents or representatives shall not be treated as Sponsors' agents for any purpose, and Sponsors are not responsible for the action or inaction of Event Sponsor, nor are Sponsors liable for any loss or penalties incurred if Event Sponsor is sold, ceases to exist, becomes inoperative; if an Event is delayed, postponed, cancelled or changed for any reason; for acts of nature; or for amenities, services and/or facilities not being available due to renovations, strikes, bankruptcy and/or acts of nature. Event Passes are issued subject to terms and conditions of Event Sponsor. In the case of mechanical difficulties, acts of God, equipment unavailability, celebrity illness or the like, Sponsors reserve the right to work with the Event Sponsor to make a reasonable substitution. If substitution is not possible, Sponsors and/or the Event Sponsor reserve the right to cancel on short notice. If an Event is delayed, postponed, cancelled or changed by Sponsors, the Event Sponsor, a third party, or for any reason, you will be notified as soon as possible. If it is not possible to substitute with an alternative date, Sponsors and/or the Event Sponsor may cancel or provide a reasonable substitute of equivalent or greater value. Notwithstanding anything to the contrary in these Terms and Conditions or otherwise, Sponsor will not offer cash substitution or refunds or be liable in any way for expenses that you incur related to Event that has been cancelled by the Event Sponsor, except in its sole and absolute discretion.

FINALIST CONFIRMATION PERIOD & FINALIST ACCEPTANCE: Potential Finalists will be notified by the Administrator on or about Monday, October 25, 2021 by email and/or telephone. Each potential Finalist will be required to sign and return, within three (3) days of notification, an Affidavit of Eligibility, a Liability Waiver, and where allowable, a Publicity Release (the "Releases"), or, if Finalist resides in Canada, a Declaration & Release Form (the "Declaration"). The Releases/Declaration will also require the Finalist to verify the information provided in the Nomination Form and to agree to accept the Finalist Prize, attend the 2021 ARA Conference and participate in the Second-Round Judging. Travel Companion of Finalist will also be required to sign a Travel Companion Liability & Publicity Release. Noncompliance will result in disqualification and the Candidate with the next highest judging score will be deemed a potential finalist.

Each Finalist will also be required to submit to a background check to confirm eligibility and help ensure that the use of any such person in advertising or publicity for the Promotion will not bring Sponsors into public disrepute, contempt, scandal or ridicule or reflect unfavorably on the Promotion or Sponsors, as determined by Sponsors in their sole discretion. Sponsors reserve the right to disqualify a potential Finalist

Once a potential finalist is verified as eligible, he/she will be declared a verified finalist (a "Finalist"), receive the Finalist Prize and continue on to Second-Round Judging Period. Fewer than three (3) Finalists may continue on to the Second-Round Judging without liability to the Sponsors or its designees of any kind.

**SECOND-ROUND JUDGING, GRAND PRIZE WINNER DETERMINATION & ANNOUNCMENT:** The Second-Round Judging & Grand Prize Winner Determination Period will occur during the 2021 ARA Conference. Each eligible Finalist will be interviewed by representatives of the Sponsors. Each interview will be judged based on the following equally weighted judging criteria to determine one (1) Grand Prize winner (the "Grand Prize Winner").

- A. Service quality and consistency over time in application
- B. Organizational and customer impact—teamwork, mentoring, training and leadership
- **C.** Service to the local community

The Finalist that receives the highest total scores based on the judging criteria will be deemed the Grand Prize Winner. In the event of a tie, the tied Finalists will be evaluated based solely on Criteria C "Service to the local community". If an additional tie breaker is needed, the tied Finalists will be evaluated based on Criteria A through B, in sequence, to the extent needed, to determine the Grand Prize Winner. All decisions made by Sponsors and Judges will be final.

The Grand Prize Winner will be announced during the 2021 ARA Conference. If the Grand Prize Winner announcement does not take place during the 2021 ARA Conference, it will take place shortly thereafter.

The Grand Prize Winner will be required to sign and return a Grand Prize Acceptance Form and an IRS W9 Form (the "Prize Acceptance Documents") within five (5) days of receipt from the Administrator or Sponsors. - Grand Prize winner's co-op will have the opportunity to use a 2022 Fendt Rogator for up to 100 hours of usage over 4 weeks during a timeframe in 2022 to be determined by the Sponsors in their sole discretion.
